(Please note that this is simply a list of jobs that our volunteers currently do; it is not a list of jobs we are currently seeking to fill.)

"Shelver": Shelves items (Books, DVD's, etc...) that have been returned to the library to their designated spot in the library.

- -Children's Shelver: Specifically works in the Children's Section shelving items.
- General Shelver: Specifically works in the Adult and Young Adult sections shelving items.

<u>Shelf Reader</u>: Goes through shelves to make sure that items are where they are suppose to be in the library and in their correct order (like the "Shelver", this job can be specified as either Children's Shelf reader or General Shelf depending on the volunteer's preference and/or age).

<u>Disc Cleaner</u>: Goes through the DVD, CD, and Books on CD collections to clean the "dirty" discs and make sure they are in playable condition.

Book Mender: Mainly mending book spines. This job <u>does</u> require having book mending experience.

Book Coverer: Covering books with protective plastic cover.
